D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;


E) Medstar Pharmaceutical Enterprises LLP the Second Party is engaged in leading business of pharmaceutical, retailing and marketing.


## CLAUSE 2 SCOPE OF THE MOU



2.9 There is no financial commitment on the part of the Deshabandhu Mahavidyalaya, Chittaranjan, and the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### **CLAUSE 3 INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know- how, inventions, patents, copy rights and designs) of the other Party.


### **CLAUSE 4 VALIDITY**
