



E) Arpa Trading Pvt. Ltd. the Second Party is engaged in leading Business Services.




CLAUSE 1 CO-OPERATION






CLAUSE 3 INTELLECTUAL PROPERTY



Ltd., the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
