BETWEEN




AND

D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;.


E) CEMCO Marketing the Second Party is engaged in leading business in cement and minerals warehousing, logistics and marketing.



CLAUSE 1 CO-OPERATION

Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.






CLAUSE 3 INTELLECTUAL PROPERTY



The term may be extend for further period by mutual consent in writing by the parties, during which period CEMCO Marketing, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of CEMCO Marketing, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
