

### CLAUSE 1 CO-OPERATION







- 2.7 Faculty Development Programs: Second Party to train the Faculties of First Party for imparting industrial exposure/training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein
- 2.9 There is no financial commitment on the part of the Deshabandhu Mahavidyalaya, Chittaranjan, and the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know- how, inventions, patents, copy rights and designs) of the other Party.

### CLAUSE 4 VALIDITY

4.1 This Agreement shall be initially valid for a period of 03 years commencing from the date of the agreement that is 6th day of February Two Thousand Twenty Three (06/02/2023). The term may be extend for further period by mutual consent in writing by the parties, during which period Coco County Hotels And Resorts Pvt. Ltd, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Coco County Hotels And Resorts Pvt. Ltd, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
